

PET LIABILITY AGREEMENT

In consideration for the Liz McGrath Collection (the “Hotel”) permitting me to keep my pet in the room assigned to me, I, the undersigned **Guest**, hereby agree to the following:

1. I confirm that the Hotel, in its sole discretion, has the right to allow or refuse the admission of any pet whatsoever, at any time.
2. In general, maximum allowable pets per room are 2, and each must weigh less than 15kgs. *(Note: Should your pet be above 15kgs, please make direct contact with our reservations team so we can consider potential exceptions on an individual basis and in our sole discretion.)*
3. I agree to pay the Hotel, immediately on demand, all charges for any cleaning or repairs due to any stains and/or damage caused by my pet, as determined within the sole discretion of the Hotel. I hereby authorize my credit card on record to be charged for the costs of these additional services.
4. My pet will remain within my control at all times.
5. When leaving my room, my pet will be on a leash or in a proper carrier at all times.
6. My pet may remain alone in my room only so long as the pet is well-behaved and in a carrier. I understand that if my pet is in a room, I must be present for the room to be serviced by any person (i.e., housekeeper, engineer, etc.), it being my sole responsibility to ensure the safety of any such person.
7. If my pet is disturbing other guests/staff or causing damage, then it cannot be left alone in my room and must remain in my control at all times. In this regard, the Hotel can instruct me, in its sole discretion, to keep my pet in my direct control at all times.
8. I must properly remove and dispose of any litter or waste associated with my pet on Hotel premises, to include while walking my pet on Hotel grounds.
9. With the exception of authorized service animals, pets are not allowed in the restaurants, spa or swimming pool areas, or any other areas that the Hotel may designate from time to time.
10. My pet’s stay at the Hotel is entirely at my own risk.
11. I agree that should my pet become sick, injured or die on the premises of the Hotel, or at any time during or after my stay at the Hotel, the Hotel will not be liable to any extent whatsoever, even if such sickness, injury or death arises from a negligent act or omission

by the Hotel, its staff or contractors. In this regard, I hereby agree to waive any such claims against the Hotel, including its owners, staff and contractors.

12. I warrant that my pet is not a danger to other animals and to humans.
13. I agree that should my pet harm/injure any guest/animal/person on hotel premises, I will be solely liable.
14. I agree that I will be solely liable for any damages and costs whatsoever arising from or related to the conduct of my pet, including (but not limited to) any injury, harm or loss caused to any person, property or animal.
15. In this regard, I hereby agree to indemnify the Hotel (including its owners, staff and contractors) and hold it harmless against any claims whatsoever arising from or related to the conduct of my pet.
16. I understand that Housekeeping must enter my room daily to inspect for damages, regardless of a "Do Not Disturb" sign on the door.
17. I agree that my pets are not allowed to sit directly on furniture or bedding, and I may not use the Hotel's towels or linens to bathe pets.
18. I agree that I am responsible for the noise my pet creates and will ensure that my pet does not disrupt the quiet enjoyment of other Hotel guests.
19. I agree that should the Hotel determine in its sole discretion that my pet is objectionable to other Hotel guests, I must immediately make other arrangements to house the pet outside the Hotel.
20. I confirm that my pet has all required and up to date vaccinations and inoculations and does not have any communicable illnesses or diseases. I can produce those records on arrival at the hotel.
21. In general, I agree that I am solely responsible for my pet's wellbeing and its conduct whilst staying at the Hotel.
22. I understand that I remain fully liable and bound by all the terms of this Agreement even if I am not the owner of the pet.

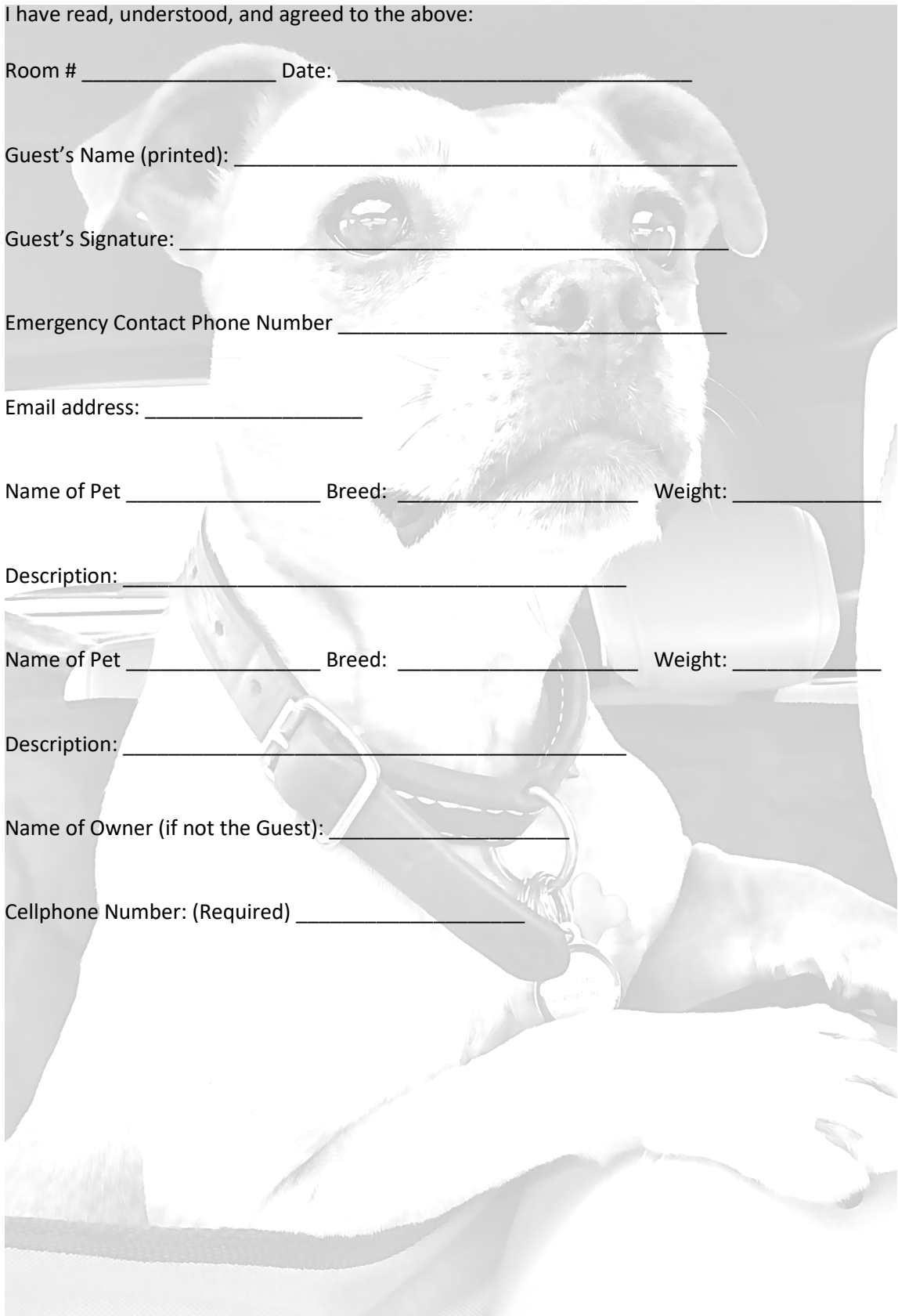
